## **Site Context**

Scotts Wood Park is a sustainable extension to Bushey. The site is bounded by residential development, the Lincolnsfield Centre and the Queens and Purcell Schools on Aldenham Road.

The site is the former Bushey Hall Golf Club, which has been closed since 2019. The site is previously developed land and comprises around 41 hectares of hardstanding, former buildings and existing grassland and trees in the central and southern portions of the site. The site also benefits from an implemented planning permission for a new club house / event space along with 31 large luxury apartments.

#### Opportunities to provide a sustainable new community.

The proposed development will be brought forward as a hybrid application for up to 400 high quality new homes comprising of a mix of 2,3,4-bedroom houses and 1 & 2 bed apartments.

The plans will include up to 70% affordable housing, and will help Hertsmere tackle its chronic shortage of affordable housing and maximise opportunities for home ownership.

## Sustainability

We are committed to having a positive environmental impact on our developments, which also conforms to Hertsmere's sustainability goals. A range of measures will be undertaken to provide attractive landscaping and enhance biodiversity:

### Sustainable design

- Utilises a 'Fabric First' approach, which will minimise carbon emissions by reducing demand for heat and power through well-insulated, energy efficient building fabric and services.
- Incorporates measures to limit heat loss through passive solar gain and cooling through the orientation and layout of the development, careful detailing to avoid thermal bridging and setting good air-tightness targets.
- Incorporates renewable energy such as air source heat pumps and solar panels.
- Adapts to future climate change scenarios by designing to mitigate overheating risk.
- Minimise waste during construction.

#### **Drainage and water conservation**

- · Minimises the use of water and grey water recycling.
- Incorporates sustainable drainage features such as SuDS and attenuation basins.

#### Sustainable travel options

 Promotes sustainable travel and transport through enabling the use of public transport, cycle storage and parking and Electric Vehicle (EV) charging points.



# Highways and Access

#### Site access

The site benefits from a number of opportunities to improve access and connectivity on the site. Three entry points are proposed:

- The southern access on Bushey Hall Drive is the main residential access.
- 2 The secondary access on Bushey Mill Lane will act as an emergency access to the north-east and provide vehicular, pedestrian and cycle access to the the community hub.
- An access will be provided to the north-west to facilitate access to the school and create further pedestrian and cycle links.



### Promoting local connections and public accessibility in the area

The site is currently not publicly accessible given it was previously a private golf course. The site will be able to meet local travel need and connectivity because:

- The site has huge opportunities to utilise existing access points to shops, services, open spaces and public transport modes.
- The proposals will include new footpaths, woodland walks and cycle ways to promote health and wellbeing by opening up the site for public use.
- There is good public transport accessibility with Watford and Bushey, including existing bus services on Park Avenue and future bus extension services from A41 Elstree to Radlett.
- There are opportunities for enhanced cycle connections, including the Beryl e-bike scheme in North Bushey.
- The site will provide connections linking local roads such as Park Avenue and Aldenham Road - which previously had no access through the site.
- We are working with Herts County Council to provide extra sustainability measures to complement these connections and further details will be submitted with the application.
